NO SC RELIEF FOR KEJRIWAL

GAURAV VIVEK BHATNAGAR

Delhi chief minister Arvind Kejriwal on Monday did not get any relief from the Supreme Court on his petition against his arrest by the Enforcement Directorate in the Delhi liquor policy case. The apex court directed the ED to file a reply by April 24 and listed the matter for the week beginning April 29.

Kejriwal had sought early listing of his petition but the court did not grant him that. The matter was listed before the Bench of Justices Sanjiv Khanna and Dipankar Datta. Appearing for Kejriwal, his

counsel, Abhishek Manu Singh, submitted that he had demanded an early hearing in the case. He tried to reason the same by saying that he had "some facts" to show and that these would "shock the conscience of the court". Singhvi also maintained that there had been "some selec-



tive leaks" in the case. Singhvi urged that the matter be listed on an "extremely short date" and suggested that it could be "possibly this Friday".

He then went on to argue how this was a "very unusual matter", not because it concerned a chief minister, but because Kejriwal had not been named in either the First Information Report (FIR) or the Enforcement Case Information Report

(ECIR) or the eight chargesheets filed by the ED and the CBI thus far.

Apart from this Singhvi also questioned the timing of Kejriwal's arrest saying, "the story began in September 2022 and he was arrested on March 21, 2024." Singhvi said in this period there were 16 statements of which 10 were by one person, Sarath Reddy, the director of Aurobindo Pharma. The remaining six statements were by others. The senior advocate said while "15 statements" had not mentioned Kejriwal, only "one statement becomes positive." And he said this was used to arrest his client that too after the announcement of the model code of conduct for the Lok Sabha elections.

The idea, Singhvi said, was to "disable me (Kejriwal) from campaigning". He then pointed out that the voting for the first phase of Lok Sabha elections is to take place on April 19. Appearing for the

ED and Centre, the Solicitor General of India Tushar Mehta objected to the grant of an early hearing and the arguments forwarded by Singhvi.

On hearing both sides, the Bench issued the order that the hearing will take place in the week starting from April 29. It also said the respondent will file its reply on or before April 24 and a rejoinder if any by April 26. Stating that this was the shortest possible date it could provide, the Bench also asked Singhvi to "reserve the arguments" for the next date.

Incidentally, Singvi had moved the Supreme Court against the April 9 order of the Delhi High Court which had rejected Kejriwal's appeal against his arrest saying the ED had placed enough material on record to show his involvement in the case. The agency had claimed that he was the key conspirator and kingpin of the scam.

SC pat for Rly's Kavach

The Supreme Court on Monday appreciated the steps taken by the Indian Railways to prevent train accidents, including the automatic train protection system 'Kavach', to avoid collisions.

"We appreciate the steps taken by the Railways," the bench said, taking note of the status report filed by Attorney General R Venkataramani.

RTI: No provision to keep records under CAA rules

There is no provision under the Citizenship (Amendment) Act, 2019 and its rules, notified on March 11, to maintain records of citizenship applications filed online under the law, according to an RTI reply by the Union Home Ministry.

The ministry's response came to RTI applications filed by Bangla Pokkho, an organisation that claims to work for the rights of Bengalis, seeking information on the number of people who applied for citizenship through the website provided by the Home Ministry on March 12 and 13,

the two days following the notification of the CAA rules.

The Union Home Ministry in a communication (F No 26027/94/2024-IC-L April 15, 2024) stated, ". that the records are not being maintained as desired by you because the Citizenship Act, 1955 & Citizenship (Amendment) Act, 2019 and the rules made thereunder does not have the provision to maintain the records of Citizenship application received. Further, as per the RTI Act, 2005, CPIO is not authorised to create information. Hence the information sought may be treated as NIL," said the communication.

All will regret it: PM

The PM's comments come in the backdrop of Delhi Chief Minister Arvind Kejriwal's arrest last month in connection with the alleged liquor policy scam.

LEVEL-PLAYING FIELD: The Prime Minister also denied allegations that the new law allows the government to have its handpicked poll panel officials. He told ANI, "In fact, we have made several improvements. Today, when the Election Commission is constituted, the opposition also plays a role in it." He was referring to the law mandating the Leader of the Opposition as the third member of the selection panel. The other two are

the PM and a Union Minister. Asked about possible investment in India by Tesla, Inc. boss Elon Musk, the PM said he welcomed all such initiatives but pitched for localisation, saying "the product should have the essence of our soil".

KISSI KO DARNE KI ZAROORAT NAHIN HAI: In the exhaustive interview, the PM also fended off questions on "Modi ki guarantee", One-Nation-One Election, his 100-day blueprint and the long-term roadmap for 2047, when India turns 100. "I have big plans...kissi ko darne ki zaroorat nahin hai (no one needs to fear it). My decisions are not made to scare anyone or to diminish anyone. They are for the overall development of the country," PM Modi said, when asked about his "Abhi toh trailer hai" comment on the last decade of the NDA government.

Air turbulence for Rahul, now

Addressing the media, party spokesperson Jairam Ramesh said Congress leaders are being targeted by central agencies. "The day before yesterday, my car was checked, my shaving cream was taken out, my toothpaste was taken out, my entire suitcase was taken out. I remained silent, I said, whatever has to be done, do it. ...check the Prime Minister's chopper, check the Home Minister's chopper, check all the choppers, level the playing field (should be there)," he said.

"You are an impartial institution, a constitutional institution, understand your rights and treat all parties equally. Don't give special category status to the Prime Minister, don't give special category status to the Home Minister. If you want to check the vehicles, do it, if you want to check the chopper, do it, we have no objection," he said.

Meanwhile, in New Delhi, Election Commission sources clarified to the PTI that surveillance and inspection of non-scheduled aircraft and helicopters by the agencies during poll season is part of standing instructions

HC upholds right to sleep

His plea mentioned that he had appeared before the agency every time he was issued summons.

Heat stirs up city dust bowl

On Sunday, the day temperatures in the suburbs had soared to 33.2 °C, with a maximum temperature of 32 °C being recorded at the Colaba observatory, while a minimum temperature of 25.6 °C was recorded at the Santacruz station.

Meteorologists anticipate above-normal temperatures to rise by at least one or two degrees Celsius throughout Maharashtra this summer.

Thane, Raigad, and several other districts too are hot

under the collar, with temperatures well above the comfort zone. The IMD warning is cue for the public to take the necessary precautions to combat the inclement weather.

Malegaon recorded the highest maximum temperature of 42.6°C, making it the hottest location in the state. Jeur and Jalgaon followed closely, with temperatures peaking at 41.5 °C each. In the Thane-Belapur Industries Association (TBIA) area, there were sweltering conditions, with the temperature reaching 41.0 °C. In Ahmednagar, Satara and Nasik, the mercury touched 40 °C.

Ratnagiri and Alibag experienced relatively lower but still significantly high temperatures.

The civic administration in Mumbai has already issued guidelines for people to cope with the heatwave, emphasising the importance of staying hydrated, avoiding direct exposure to sunlight in peak hours, and seeking medical assistance in case of heatrelated illnesses. Residents have been advised to stay indoors as much as possible and take adequate measures to beat the heat. Relief measures for vulnerable sections of the population, such as the elderly, children and the homeless individuals have been put in place in view of the extreme weather.

But expect above...

The IMD chief said there is a 29 percent chance of normal rainfall, 31 percent chance of above-normal rainfall and 30 percent chance of excess precipitation during the monsoon season.

According to the IMD, rainfall between 96 per cent and 104 percent of a 50-year average of 87 cm is considered 'normal'.

Rainfall less than 90 percent of the long-period average is considered 'deficient', between 90 percent and 95 percent is 'below normal', between 105 percent and 110 percent is 'above normal' and more than 100 percent is 'excess' precipitation. Data from the 1951-2023 period shows India experienced above-normal rainfall in the monsoon season on all the nine occasions when La Nina followed an El Nino event, Mohapatra said. The country gauged above-normal or

normal monsoon in 20 out of the 22 La Nina years. El Nino conditions are prevailing at present. ENSO neutral conditions are expected in the first half of the monsoon season. Thereafter, models suggest, La Lina conditions may set in by August-September,

Mohapatra said.
Positive Indian Ocean Dipole conditions, favorable for the Indian monsoon, are predicted during the season.
Also, the snow cover in the Northern Hemisphere and Eurasia is low. Therefore, all the conditions are

conducive, he said.

El Nino conditions -- periodic warming of surface waters in the central Pacific Ocean -- are associated with weaker monsoon winds and drier conditions in India. La Nina conditions - the antithesis of El Nino -- are the dominant factor in the likelihood of "abovenormal" rainfall during the monsoon season, D S Pai, a senior scientist at the IMD, said.
